1. Mayor's announcements.

Chris Craig noted the recent passing of Ranson resident Clark Dixon, who assisted with a number of notable projects in the local community.

Town Attorney Kin Sayre pointed out minor changes to the ordinance with regard to the company name, but he feels these are not substantive changes from the text as approved during first reading for approval of the ordinance.

Comments were provided by seven members of the public:

- Barbara Humes stated that the ordinance needs corrective editing. She distributed a list of suggested corrections to the Town Council.

- George Owens noted that the corrective deed seems to transfer a lot of formerly public property to a new entity compared to the original (2021) deed.
- Bryan Gray spoke in support of the deed and ordinance.
- Pasha Majdi spoke in support of the deed and ordinance.
- Eddie Love, president of the Merchants Association, spoke in support of the deed and ordinance.
- David Simmons said that most of the problems identified in the recent Citizens' lawyer's letter have been corrected; however, he felt that some changes from the original deed are problematic.
