a. Discussion and Action on Application to Alter Public Right-of-Way at 699 Fillmore Street

b. Discussion and Action on Public Safety Concerns at 991 Putnam Street

Karen and Louis Sagasi addressed the Commission regarding the volume of vehicles as well as public urination on Putnam Street. They noted nine separate instances of public urination on Putnam Street over the past two years and as many as 120 cars per day along Franklin Street. Mr. Sagasi indicated concern for the safety of his family and neighbors and also about sanitation in the area. A possible barrier to non-residential traffic was discussed and dismissed. Directional signs so that people are able to find the location of the Hilltop House was discussed. Mr. Craig noted that residential parking signs can be requested by residents of the area.

Following discussion, Mr. Dill made a motion to forward several suggestions to the Town Council for their consideration to potentially alleviate the discussed issues.
