Petitioners move for leave to file a two-page supplemental appendix. *See* W. Va. R. App. P. 7(g). Good cause supports this modest request.

First, the two documents contained in the proposed Supplemental Appendix, attached hereto as an exhibit, are necessary and relevant to issues raised by Respondents in their response brief, including a cross-assignment of error. The first document is a copy of the official Board of Canvassers Certification of Results from the 2019 Harpers Ferry Municipal Election. The second document is a copy of municipal record provided to the undersigned in response to a FOIA request that demonstrates Leah Howell's decision, prior to the election, to withdraw her candidacy.

Second, the two documents are public records that are subject to judicial notice, as they are not subject to reasonable dispute. See W. Va. R. Evid. 201(b); see Zak v. Chelsea Therapeutics Int'l, Ltd., 780 F.3d 597, 607 (4th Cir. 2015) (under Federal Rule of Evidence 201(b), "courts at any stage of a proceeding may judicially notice a fact that is not subject to reasonable dispute, provided that the fact . . . can be accurately and readily determined from sources whose accuracy cannot reasonably be questioned") (cleaned up). Indeed, the two documents here only serve to confirm undisputed facts—1) the current, certified vote tallies, and 2) Howell's express decision to disavow pursuing a position on the Harpers Ferry Town Council even before the election.

Accordingly, the motion for leave to file the proposed Supplemental Appendix should be granted and the Supplemental Appendix deemed filed.
